## In Memory

**John D. Wrasse, MD**, graduated from the IU School of Medicine in 2005, and returned to Bloomington in 2008 to begin his pediatric practice. When he started as a pediatrician, he was a little older than most new physicians. Unfortunately, he only had 13 short years of practice before he passed away at the young age of 53. From a young age Dr. Wrasse loved cycling, and that is what he was enjoying until the very hour of his death.



In 1991, John moved to Bloomington to begin a career working at Indiana University, where he met his future wife, Lisa. While in Bloomington, he continued his love of cycling. He rode with the Bloomington Bicycle Club and in the Hilly Hundred, and even worked part-time with the Bloomington Bicycle Garage.

At age 35, as a non-traditional student, John became a first-year medical student on the IUSOM Bloomington campus. He graduated from med school in 2005 and then completed his residency in pediatrics.

His pediatric career was short, but he made his mark in our local medical community and with his patients and their families. He loved his patients, and his patients loved him. Many parents thought that he was the only doctor that could treat their children. Some of his patients shared thoughts and memories of Dr. Wrasse. One mother, who works in the medical field shared, *“Dr. Wrasse was certainly the best doctor I’ve ever met.”* Another mother said, *“He had an amazing way of communicating with my kids. They loved to go see him, even on their sickest days.”* One thing was clear, as it was shared by his staff AND his patients, he loved his wife and two daughters. Another of his patients said, *“I feel like I know his wife and kids because he always talked about them. His love for his family was obvious.”*

One of the things that Dr. Wrasse would often say is, *“I gotta go see a kid about a thing.”* These kids will miss their very special doctor, and pediatrics will not be the same without him. The entire local medical community will miss him, but most of all, he will be missed by his wife and daughters.

One of John’s passions was to help the next generation of physicians explore and learn in preparation to become outstanding healers. He was a passionate educator, serving for years as a clinical faculty member at IU School of Medicine. Now, in his memory, the John Dr. Wrasse, M.D., Memorial Scholarship has been established to continue his impact on IU medical students into perpetuity.

## The STEM to Them Mobile Lab Arrives at MCCSC

# New MOCMS Bylaws and Articles of Incorporation

The Medical Society now has new and updated governance documents. Earlier last month the membership approved new Bylaws by electronic vote, and on March 22, 2021 Articles of Amendment were filed with the Indiana Secretary of State. The new Bylaws bring several important changes to the governance structure of the Society, while retaining its basic role as a membership organization.

The Monroe County Medical Society was founded in 1940 (original Articles pictured above). The original Certificate of Incorporation (pictured) stated the following purposes of the society:

*“... to bring into one organization the physicians of Monroe County so that by frequent meetings and full and frank interchange of views, they may secure such intelligent unity and harmony in every phase of their labor as will elevate and make effective the opinions of the profession and all scientific, legislative, public health, material and social affairs to the end that the profession may receive that respect and support within its own ranks and from the community to which its honorable history and great achievements entitle it; and with other county societies to form the Indiana State Medical Association and through it with other state associations, to form and maintain the American Medical Association.”*

No significant changes were made to the original Bylaws (Constitution) over the next 80+ years except to welcome physicians of Owen county to the society in 1961, resulting in the renaming of the organization as the Monroe Owen County Medical Society. Early in 2019, the MOCMS Executive Committee decided to review the Bylaws. After consulting with an attorney, we determined that revisions were needed to better reflect the current operations and practices of the Society as a not-for-profit corporation and to create a governance structure consistent with other like-organizations.

Over the next 2 years, a subcommittee consisting of Drs. Carrie Davis, Tashera Perry, James Faris, and Dan Lodge-Rigal with assistance from MOCMS Director Susan Richardson and Associate Director Kim Rudolph, drafted the new Bylaws and Articles of Amendment. Drafts of the new documents were subject to multiple reviews by the Executive Committee, ISMA, and legal review. Following final approval by the Executive Committee, the documents were sent to all current MOCMS members for review, comment and voting which was completed on March 13, 2021.

The most important change in the new Bylaws is the creation of a Board of Directors (BOD), which will replace and fulfill much of the current role of the large “Executive Committee” that had been described in the original constitution. **The BOD will be elected by the membership of the Society.** A standard Executive Committee, consisting of President, President-Elect, Past-President, and Secretary-Treasurer will be elected from members of the BOD. In the transition to the new governance structure, all current and newly elected members of the pre-existing Executive Committee were transitioned to members of the BOD. An additional change will be that MOCMS delegates (*and alternate delegates*) will no longer be elected positions but will be appointed by the BOD. Any member interested in serving as ISMA delegate is encouraged to contact any member of the BOD or director Susan Richardson.

A copy of the new Bylaws and spreadsheet of changes were circulated earlier to all members. If you have any questions or concerns, or need another copy to review, feel free to contact Susan Richardson at [director@mocms.org](mailto:director@mocms.org). A separate document delineating specific details of administrative operations of the Society (*Administrative Regulations*) is currently being drafted and will be finalized this year.

Thanks to all who helped in drafting and revising the documents and all members who offered comments and voted for approval. May these new documents serve the physicians of Monroe and Owen County as well for the next 80 years!

# HealthNet Bloomington Health Center Begins Second Year

The Bloomington Health Center (BLHC), formerly Volunteers in Medicine (VIM), is three months into its second year of operations. The HealthNet mission is “*To improve lives with compassionate health care and support services regardless of ability to pay.*” Despite the pandemic, BLHC served over 1300 patients during its first year.

As a federally qualified health center, HealthNet has expanded the scope of services in Bloomington well beyond what was previously offered by VIM. The center now serves all ages – from newborns to seniors – from all geographic areas regardless of age, income, citizenship, or insurance status.

Like all HealthNet centers, HealthNet Bloomington welcomes people both with and without insurance. The center accepts Medicaid, Healthy IN Plan, Medicare, and most commercial insurances. Patients are given a sliding scale fee based on income and family size. On-site navigators help eligible people enroll in insurance plans as well.

The center is now fully staffed with providers Dr. Greg Sutliff, Theresa McClure NP, Nubia McVey NP, and Kristin Bunch NP. In addition, a full-time pediatrician is scheduled to join the center in July. The dental clinic reopened in June for dental emergencies and in the fall opened its full-service operations. Pediatrics and a focus on women’s health and pre-natal care began mid-year as well.

In addition to our primary care services, social work and support services continue to be available to our patients to address the many social determinants of health that exacerbate medical conditions. Grants and other funding allow us to offer financial assistance for people experiencing barriers to healthcare due to affordability or transportation.

In this time of COVID-19, telemedicine and virtual care have quickly become important tools in caring for our patients. Established patients at HealthNet Bloomington can schedule medical appointments using virtual tools. This approach is particularly important to help provide routine care for patients vulnerable if exposed to the virus.

We couldn’t have predicted the turbulence and uncertainty the pandemic caused during our first year of operations. However, HealthNet closely follows CDC guidelines, and we have taken every precaution at the Bloomington Health Center to provide excellent patient care while minimizing risk of exposure to the virus for our patients and staff.

# Two Years of MOCMS Book Club

In the beginning of 2019, Dr. Christal Greene had the idea that a book club would be a great way for MOCMS members to connect. She presented the idea to some committee members that a book club would be an awesome way to gather with peers, discuss books, and share meaningful conversation with a focus on revitalization and inspiration outside our typical professional interactions. In March 2019, the MOCMS book club was born with the hope that it would become a quarterly event. Two years later the MOCMS book club continues with books selected by book club attendants while alternating fiction/nonfiction to appeal to differing preferences.

Our pre-COVID meetings were held in Sherwood Green clubhouse. We discussed in March 2019 *In Shock: My Journey from Death to Recovery* and the *Redemptive Power of Hope*, June 2019 *Cutting for Stone*, September 2019 *The Immortal Life of Henrietta Lacks*, and January 2020 *Before We Were Yours*. While COVID-19 was barely in our vocabulary in January 2020, the next book club was scheduled for April. The book clubs were subsequently postponed until October 2020 giving us time to process and adjust to the changes the pandemic brought into our lives. The October 2020 book club was held at an outside shelter house at Bryan Park with *Black Man in a White Coat* providing quite thought provoking content chosen with hopes to broaden our exposure to racial disparities in medicine. In January 2021, the book club met at the Switchyard Park Pavilion, an inside shelter house with large garage doors partially opened for better ventilation but allowing more protection from the cold. The book *A Mother’s Reckoning* proved to be challenging content leaving a profound effect on our view of teen suicide and school shootings. Most book club members have enjoyed meeting outdoors and we will continue to make this a priority going forward. The next book club is scheduled for **Friday, April 23** (see invitation on the next page for details).

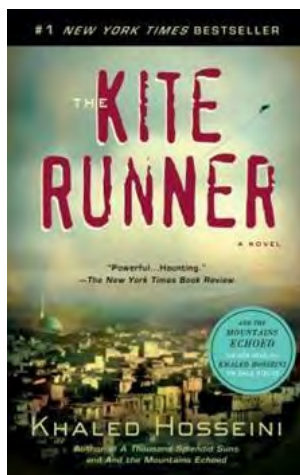
# Leaving Practice or Retiring Soon?
