MOCMS 2022 Fall General Meeting

On September 29, after three long years, MOCMS physicians and guests were able to visit and catch up with each other at Oliver Winery. Before this event, October 2019 was the last social event with physicians and guests. Thanks to Hurlow Wealth Management's generous donation, the gathering was made possible to gather and socialize. MOCMS appreciates the support from Joe Manley and John Hurlow over the past few years, and would like to remind MOCMS members:




Kudos

Dr. Strickler became interested in growing giant vegetables in 2011, when he saw a giant tomato at the State Fair. He began growing tomatoes competitively for size. He then got sucked into growing giant pumpkins & squash in 2015. He calculated that he and his wife have spent roughly 1,600 hours this year taking care of 3 Giant pumpkins, 28 Giant tomatoes and the rest of the garden.

This year his pumpkin won first prize, weighing in at 1,739 pounds. The vine grew for 5 & 1/2 months. When the pumpkin was lifted, it was 114 days old. His wife, Kathy, was a huge help and supported him in this endeavor, and he could not have done it without her. Also, in 2018 he set the state record for giant green squash at 1035.5 pounds.





The Silver-Lining to Market Declines: Tax-Loss Harvesting

Investors can employ several techniques during market downturns to improve long-term returns. One of those techniques is called "tax-loss

Tax-loss harvesting is the process of selling a security at a loss while simultaneously buying into a highly correlated security. The idea is to keep the same strategic position in the market while gaining the benefit of booking the loss on your taxes.

For example, suppose you harvest \$30,000 of long-term losses this year and that you have no other sales. You could deduct \$3,000 of those losses from ordinary taxable income and "carry forward" the remaining \$27,000 of losses to future years to offset gains or deduct from ordinary income.

Continuing the example above, let's say you are married, file a joint tax return, and in the 24% tax bracket for federal income tax, and 20% rate for long-term capital gains tax. In 2022, your potential tax savings is \$720 (\$3,000 * 24%). Then, in 2023, you sell an investment for a long-term capital gain of \$24,000, so you could save \$4.800 (\$24,000*20%) in tax liability and use the remaining losses to offset another \$3,000 in ordinary income, saving another \$720. So in this example, the taxloss harvest strategy in 2022 saves you \$6,240 over two years.





Another point to remember is that this strategy only applies to taxable brokerage accounts, not retirement accounts. One cannot deduct losses generated in a tax-deferred account such as an IRA or 401(k).

Although we cannot control the markets, it is possible to take advantage of tax savings opportunities when they arise. If you need help harvesting your losses, it might be time to work with an advisor.
